Reference of letter No. 2205/2006 Dated 26.4.06:

Addressed to The Director, All Study Institutes (Outside the State of MP); Sir, The question whether the University can continue with the association of study institutes beyond the geographical limit of the state of MP. The legal opinion confirms that the DEC has no statutory authority to question the association of the institutes by this University but the Supreme Court judgment in the Chhattisgarh University case (Prof. Yashpal V/s the State of Chhattisgarh - W.P. No. 19/04) -

"In view of Article 245(1) of the Constitution, Parliament alone is competent to make laws for the whole or any part of the territory of India and the legislature of a State may make laws for the whole or any part of the State. The impugned Act which specifically makes a provision enabling a University to have an off-campus centre outside the State is clearly beyond the legislative competence of the Chhattisgarh legislature.

In view of this stand of the SC, it is not now legally possible for the University to continue to associate institutes outside the state of MP.

Reference of letter No. 2799/2006 Dated 26.5.06:

Some of the institutes associated with this University have filed a Writ Petition in the MP High Court and the Honble High Court has been pleased to pass an interim order on 19.5.06, the operating part of which is reproduced below:

"Till next date of hearing, it is directed that respondent No. 1 shall not give effect to the order Annexure P/16 dated 26.4.2006. However, it is made clear that in case this order is vacated or the petition is dismissed, the petitioner who will collect the fee shall be under an obligation to refund the fee to the students concerned, who may be admitted in the institution of the petitioner because of the interim order of this Court.

In compliance of the above mentioned order of the MP High Court, the University is not giving effect to the said letter dated 26.4.06.
